Thanks for the update on ABC Conference

I particularly found it interesting that John Sheppard wouldn't give you a copy of the "list" - shows they're worried that it'll get into my hands so I can be prepared with documents to counter the so called 'issues' ahead of the court case.

A number of those on the list you said was due to the boxer having been imprisoned or similar.

In the UK there's a law called the Rehabilitation of Offenders Act 1974, which the BBBofC totally ignore and refuse to license those previously convicted.

We cannot understand how the BBBofC get away with this as our lawyers told us in no uncertain terms that we must strictly obey this law or risk not only possible civil proceedings from those we refuse or Government sanctions against us.

Just before Christmas last year this was published about one of our licensed boxers

When I spoke to the journalist he told me they got the tip off from the BBBofC.

Now for a little twist to the story - as I am sure you're aware Lee Churcher recently got his license from the BBBofC -
http://www.southwalesargus.co.uk/news/10192634.Welsh_boxing_champion_jailed_for_four_years_on_cocaine_conspiracy_charges/ - and as you are aware we licensed him previously.

I recommended Lee retire following his close win over Ishmael Tetteh last year as to be honest he couldn't cope with Tetteh, just Tetteh was not active enough in many of the rounds to win them and get the title victory.

Lee, never told the BBBoFC that we felt he should retire and they jumped at licensing him to get another boxer away from us.

We've had a number of our boxers literally tapped up by the BBBoFC BUT once they have their BBBoFC license all sorts of problems and obstacles are put in their way, including deliberate manipulation the results, which led to them losing when fighting on BBBoFC shows even though they had won (have seen the videos of a number of cases like these)

In one case, one boxer, Will O'Reilly, had four MBC/BIBA fights and a record 1-2-1 before going to the BBBoFC, where he had a further four fights under the BBBoFC and lost all.

I have seen video of two of these, the second fight under BBBoFC, where he won every round by a clear margin out boxing his opponent easily, yet got a loss on his record - the fans of the boxer that "won" were even booing after hearing the result!

Another one is where the referee stopped the contest for absolutely no reason whatsoever, again Will was well ahead and clearly going to win.

Will, who is now back with BIBA, states that one of his other losses came about in similar circumstances, the other he injured himself a few days before but instead of pulling out fought and genuinely lost.

So you can see why John didn't want to give you the list - but now, even though it means more work am going to put together reports on ALL BIBA boxers that will cover their medical history as well as cover any convictions they may have had ready for the lawyers so we can counter their misleading "list"

One last thing haven't heard back from WBO or WBA re my letters last week, should I follow these up or can you have a word?
